

# **GS1 Standards** for DSCSA Dispensers Online Certificate Course

Prepare for serialization and for receiving products and cases

This certificate training is designed for retail pharmacies, hospital pharmacies, chain pharmacies, and anyone preparing for Drug Supply Chain Security Act (DSCSA)\* requirements.

The U.S. Drug Supply Chain Security Act (DSCSA) was passed into law in 2013, marking the beginning of the pharmaceutical supply chain's journey through lotlevel management, product serialization, and finally item-level traceability by 2023.

In response, implementation of the DSCSA is underway across the pharmaceutical supply chain, and many industry members have been using GS1 Standards to meet those requirements.

This course is intended to prepare you for receiving products and cases from suppliers using GS1 Standards to implement the DSCSA, and to assist you in leveraging the standards for your DSCSA implementation. It will introduce and explain key concepts about GS1 barcodes used for products and homogeneous cases, GS1 Application Identifiers used to encode DSCSA data in barcodes, types of barcode scanners, and GS1 Standards that support DSCSA data exchange.
