Individuals must provide an accurate email address during the Conference registration. Employees, officers, directors, members, managers, agents and representatives of GS1 US, Inc. - b. Each attendee's name and company name will act as their unique identifier within the leaderboard.
- c. Each attendee will be awarded points for answering trivia questions correctly.
- d. Attendees may participate as frequently as they want during the three days of the Event.
- e. A leaderboard on the monitor in the Future of Data Carriers HQ area will show the ranking point earners.
- f. All entrants must follow the instructions in the "How to Play" Section below.

3. HOW TO PLAY:

a. On June 5, 2023 beginning at 8:00 PM Eastern Daylight Time, entrants may visit the 2D, RFID – What's In It for Me? - Test Your Knowledge Leaderboard Contest within the exhibit area of the GS1

Connect Unified Space in the Aurora Ballroom and Exhibit Hall at the Gaylord Rockies Resort & Convention Center.

- b. At the start of the conference (June 5th, 2023 8pm EDT) through the close of the conference will be considered the "Entry Period" (June 7th, 2023 4:15pm EDT), and entrants will have the opportunity to answer trivia questions on iPads supplied by Sponsor to earn points competing against other Contest participants attending the conference. Entrants scores will be tallied cumulatively over the days of the Event.
- c. The top three (3) point leaders in the Contest at the close of the entry period at 4:15pm EDT on Wednesday, June 7, 2023 will be named winners of the contest and notified of their status and prize distribution via email from GS1Connect@gs1us.org.
- d. The person with the most cumulative points as of 4:15pm EDT on June 7, 2023 will be the First Place Winner and awarded a pair of Apple Air Pods Max with an approximate retail value (ARV) of \$549.00 USD. The entrant receiving the second most points at the close of the entry period will be the Second Place Winner and will be awarded an Apple Watch Series 8 with an approximate retail value (ARV) of \$399.00. The entrant receiving the third most points at the close of the entry period will be the Third Place Winner and will be awarded a Meta Quest 2 VR headset with an approximate retail value (ARV) of \$399.00.

4. GAME RULES:

- a. Entrants must be present and participating in the 2D, RFID What's In It for Me? Test Your Knowledge Leaderboard Contest located within the Future of Data Carriers HQ area designated at the Event. In order to earn points. Up to (4) participants can play at once on the Sponsor-provided iPads. within the Future of Data Carriers HQ area. Entrants must enter their full name on the iPad to begin the game. Entrants have the opportunity to answer 10 trivia questions. Each correct answer will earn the entrant up to (25) points. The top (3) entrants who answers the most correct answers in the fastest time throughout the entry period will win a prize. The Leaderboard software's internal algorithm will track entrant submission scores and times and rank them in order of highest point values first. Ties will be automatically determined based on submission times.
- c. Prizes will be awarded to the top (3) point earners. Any ties in points are resolved through time to complete answers. Entrants who answer the most correct answers in the least amount of time will rank higher. The leaderboard software will track answer submissions down to the millisecond. Leaderboard report totals will be a cumulative total beginning 8pm EDT on June 5, 2023 and closing at 4:15pm EDT on June 7, 2023.
- d. Limit one (1) entry in the Contest per person. Participation may not be made jointly or by any group and may only be made by an individual. Sponsor's designated clock will be the official timekeeper for this Contest. Those who do not follow all of the instructions, provide the required information in their entry, or abide by these Official Rules will be disqualified.
- e. Those who do not abide by these Official Rules and other instructions of Sponsor will be disqualified. Entries that are delayed due to technical issues such as internet connection or other similar problems or the entry is otherwise corrupted, damaged, false, forged, copied, altered, incomplete, lost, late, misdirected, mutilated, illegible, garbled or otherwise not in compliance with these Official Rules may
