

# **How to** Build a GS1 Global Trade Item Number (GTIN) Into a GS1 DataBar Barcode for Produce

The GS1 DataBar<sup>®</sup> Stacked Omnidirectional barcode was developed for small, hard-to-mark consumer goods, like loose produce, to provide product information in less space than the U.P.C.\* barcode can.

**Note:** The GS1 DataBar Stacked Omnidirectional barcode and PLU Code will coexist on loose produce labels.

• In this publication, the letters "U.P.C." are used solely as an abbreviation for the "Universal Product Code," which is a product identification system. They do not refer to the UPC, which is a federally registered certification mark of the International Association of Plumbing and Mechanical Officials (IAPMO) to certify compliance with a Uniform Plumbing Code as authorized by IAPMO.

# **Creating Your GS1 DataBar Barcode**


#### **1.** Add pad zeros to make it the required 14-digit format

In order to encode your GTIN into a GS1 DataBar barcode, you need to convert your GTIN into a 14-digit format. You can do this by adding pad zeros.

### 2. Print

## Anatomy of GS1 DataBar Stacked Omnidirectional Barcode



\*A GS1 Application Identifier (AI) is a field of two or more digits at the beginning of an element string that uniquely identifies the format and meaning within the GS1 System of Standards. The AI (01) indicates that the GS1 AI data field contains a GTIN. This AI is fixed in length and encodes 14 numeric digits.
